The Mandal Educational Officer, Patancheru, Sangareddy has verified the proposals with reference to the conditions laid down in the Recognition orders and GO Ms No 1/Edn, Dated: 01-01-1994 and subsequent Government Orders submitted a detailed report through the letter under reference 4th read above.

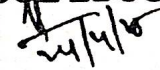
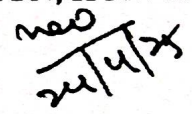

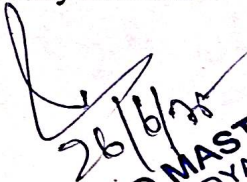
